- 2) **Previous Minutes 12/10/22** This was the first official AGM as last year the meeting was held to setup the association and adopt the constitution.

- Chair's Report SC opened the meeting by greeting all new parents and introduced Buckton Buddies (BB) with a presentation. SC covered what the PTA is and its main objectives, the structure of the association, upcoming events and how/when parents can get involved.
